

## **T's & C's for Win A Trip to a Bush Lodge**

- The Promotion begins on 8 September 2023 and ends on 31 October 2023 (the "Promotion Period"). Winner will be announced shortly after the promotion ends.

In the event that production, technical, seeding, programming or any other reasons cause more than stated number of prizes as set forth in these Official Rules to be available and/or claimed, Main Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
